<p>Beef & Liberty Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) No person shall be allowed to carry any glass receptacles at the veranda of the premises on Halloween, Christmas Eve and New Year's Eve; and (b) No consumption of liquor at the veranda of the premises between 11:00 p.m. and 9:00 a.m. the following day. <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
