Dusk Till Dawn Application for Renewal of Liquor Licence	Agreed to issue a 9-month liquor licence with the retention of existing additional licensing conditions.
Comptoir Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions and the imposition of the following additional licensing condition: The licensee shall ensure that liquor sold or supplied shall be consumed on the premises only.

PIZZA CO Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; (b) No sound amplification device or TV shall be switched on and no music shall be played on the premises between 11:00 p.m. and 9:00 a.m. the following day; and (c) The licensee shall with due diligence ensure that liquor sold or supplied shall be consumed on the premises only. <p>(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>
