PICI Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: (a) All doors and windows of the premises shall be kept closed between 10:00 p.m. and 9:00 a.m. the following day; (b) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 9:00 a.m.; (c) No liquor shall be sold or supplied for consumption in the licensed area outside the main entrance of the premises between 10:00 p.m. and 9:00 a.m. the following day; and (d) No tables or chairs shall be placed in the licensed area outside the main entrance of the premises between 10:00 p.m. and 9:00 a.m. the following day. (The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)
