A SIDE & B SIDE 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件： (a) 晚上 8 時至翌日上午 9 時，處所的所有門窗必須保持關閉； (b) 晚上 10 時至翌日上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用； (c) 晚上 11 時至翌日上午 9 時，不得在處所內飲用酒類飲品； (d) 晚上 10 時至翌日上午 9 時，處所內不得將擴音設備或電視機開著，也不得演奏或播放音樂；及 (e) 持牌人須盡應盡的努力，確保售賣或供應的酒類飲品只供顧客於處所內飲用。
PIZZAEXPRESS 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件： (a) 晚上 11 時至翌日上午 9 時，處所的所有門窗必須保持關閉；及 (b) 晚上 11 時至翌日上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用。 (由於有關處所目前只持有暫准普通食肆牌照，按現行政策，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)

<p>Pampas Argentinian Steak House Application for Transfer of Liquor Licence</p>	<p>Approved application for transfer of liquor licence with the retention of existing additional licensing conditions.</p>
<p>ESTIATORIO KEIA Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing condition:</p> <p>No liquor shall be consumed in the area of one-meter distance from the parapet at the flat roof of the premises at all times.</p> <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
