**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案 Case</b>	<b>酒牌局的決定 Liquor Licensing Board's Decision</b>
<b>Chez Patrick</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  i) The front doors of the premises shall be kept closed after 6:00 p.m.; and  ii) No liquor shall be sold or supplied for consumption on the premises after 1:00 a.m.  ( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )
<b>Penthouse</b> 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件：  在任何同一時間內，店舖的人數連同職員在內不得超過 172 人。  (由於有關處所目前只持有暫准小食食肆牌照，按現行政策，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)

<p><b>Here</b> 新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> <li>i) 晚上 10 時後，處所的前門必須保持關閉；及</li> <li>ii) 凌晨 3 時後，不得售賣或供應酒類飲品供顧客在處所內飲用。</li> </ul> <p>(由於有關處所目前只持有暫准小食食肆牌照，按現行政策，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
<p><b>三點水泰食</b> <b>Aqua Snack Bar</b> 酒牌轉讓及修訂(更改店號及業務性質)申請</p>	<p>批准酒牌轉讓、修訂店號及更改業務性質申請，除維持酒牌上原有的附加持牌條件外，另附加下列條件：</p> <p>晚上 11 時後，不得使用卡拉 OK 設施。</p>
<p><b>聚富軒飯店</b> <b>Tsui Fu Hin Restaurant</b> 酒牌續期申請</p>	<p>拒絕酒牌續期申請。</p>
