Beo Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  i) All doors and windows of the premises shall be kept closed after 11:00 p.m.;  ii) No liquor shall be sold or supplied for consumption on the premises after 3:00 a.m.; and  iii) Not more than 106 persons on G/F and 20 persons on LG/F, including staff, shall be permitted on the premises at any one time.  (The premises are currently applying for a General Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)

## **Pickled Pelican**

Application for Renewal of Liquor Licence

Agreed to issue a 6-month liquor licence with the retention of existing licensing conditions and the imposition of the following additional licensing condition:

The licensee shall be on duty on the premises from 6:00 p.m. to 2:00 a.m. next morning on Thursdays, Fridays, Saturdays and on the eve of days preceding Public Holidays.
