**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案 Case</b>	<b>酒牌局的決定 Liquor Licensing Board's Decision</b>
<b>D Corner</b> 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件：  i) 晚上 11 時後，不得有人逗留在處所的露台；  ii) 晚上 11 時後，處所的所有門窗必須保持關閉；及  iii) 在任何同一時間內，店舖的總人數連同職員在內不得超過 80 人。  (由於有關處所目前只持有暫准普通食肆牌照，按現行政策，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)

<p><b>Canucck</b> Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>i) All doors and windows of the premises shall be kept closed after 6:00 p.m.; and</li> <li>ii) No liquor shall be sold or supplied for consumption on the premises after 11:00 p.m.</li> </ul> <p>( The premises are currently applying for a General Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )</p>
<p><b>老坑美食</b> 新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌。</p> <p>(由於有關處所目前只持有暫准普通食肆牌照，按現行政策，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
<p><b>新嘉樂斯卡拉 OK</b> <b>夜總會</b> <b>New Galaxy Karaoke</b> <b>Night Club</b> 酒牌續期申請</p>	<p>同意續發為期 3 個月的酒牌，並維持酒牌上原有的附加持牌條件。</p>
<p><b>金晚夜</b> <b>Day &amp; Night</b> 酒牌續期申請</p>	<p>同意續發為期 9 個月的酒牌，並維持酒牌上原有的附加持牌條件。</p>
