<b>Sugardolls</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence.  ( The premises are currently applying for a Light Refreshment Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )

<p><b>The Real Bread Cafe</b> Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>i) All doors (including the back doors leading to the alley) and windows of the premises shall be kept closed after 11:00 p.m.; and</li> <li>ii) No liquor shall be sold or supplied for consumption on the premises after 2:00 a.m.</li> </ul> <p>( The premises are currently applying for a General Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL.
