**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案 Case</b>	<b>酒牌局的決定 Liquor Licensing Board's Decision</b>
<b>Club 97</b> Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing condition and the imposition of the following additional licensing conditions: <ul style="list-style-type: none"><li data-bbox="698 651 2031 900">i) A recording CCTV system shall be installed and operational inside the premises covering and recording the entrance to both the male and female toilets and the vicinity thereof. The positioning of such CCTV system should not be within the toilet or impinge upon the privacy of any person within or using the toilet. The recorded images to be maintained by the licensee for a minimum period of one calendar month and to be made available to Police as required or requested by Police;</li><li data-bbox="698 943 1951 975">ii) No person under the age of 18 shall be permitted to enter or remain on the premises;</li><li data-bbox="698 1018 2031 1091">iii) Not more than 74 persons, including staff, shall be permitted on the premises at any one time; and</li><li data-bbox="698 1134 2031 1208">iv) No speaker or other sound amplification of the premises is to be used after 11:00 p.m. either outside the premises or within the structure of the premises facing outwards.</li></ul>

<p><b>Home Base</b> Application for Transfer and Renewal of Liquor Licence</p>	<p>(a) Approved application for transfer; and</p> <p>(b) Agreed to issue a 12-month liquor licence with the retention of existing additional licensing condition and the imposition of the following additional licensing condition:</p> <p style="text-align: center;">No music or other sound amplification shall be played or used after 5:00 a.m.</p>
<p><b>Anchor's Point</b> Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <p style="padding-left: 40px;">i) All doors and windows of the premises shall be kept closed after 6:00 p.m.; and</p> <p style="padding-left: 40px;">ii) No liquor shall be sold or supplied for consumption on the premises after 1:00 a.m.</p> <p>( The premises are currently applying for a Light Refreshment Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>

<p><b>我的意大利廚房</b>  <b>La Cucina Italiana</b>  新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> <li>i) 凌晨 1 時後，不得售賣或供應酒類飲品供顧客在處所內飲用；及</li> <li>ii) 按屋宇署的評估在酒牌上附加持牌條件，限制處所可容納的人數上限。</li> </ul> <p>(由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘若有關處所只獲發暫准普通食肆牌照，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
<p><b>順德魚王邨</b>  <b>Shun Tak Fisherman's Village</b>  新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌。</p>
<p><b>金豪華卡拉 OK 夜總會</b>  <b>Kam Hoo Wah Night Club</b>  酒牌續期申請</p>	<p>同意續發為期 3 個月的酒牌，並維持酒牌上原有的附加持牌條件。</p>
<p><b>星寶娛樂卡拉 OK 夜總會</b>  <b>Sing Po Entertainment Karaoke Night Club</b>  酒牌轉讓申請</p>	<p>同意批准酒牌轉讓申請，並附加下列持牌條件：</p> <ul style="list-style-type: none"> <li>(i) 在任何同一時間內，處所的總人數連同職員在內不得超過 268 人；</li> <li>(ii) 持牌人須於每天下午 6 時至翌晨 2 時留駐處所當值，每週星期日例假除外；及</li> <li>(iii) 持牌人須確保 18 歲以下人士不得進入處所。</li> </ul>
