| Simplicity Application for New Issue of Liquor Licence | Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: <ul style="list-style-type: none">i) All doors and windows of the premises shall be kept closed after 11:00 p.m.; andii) No liquor shall be sold or supplied for consumption on the premises after 2:00 a.m. (Since the premises are currently issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.) |
