The Globe Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: i) All doors and windows of the premises shall be kept closed after 11:00 p.m.; and ii) No liquor shall be sold or supplied for consumption on the premises after 2:00 a.m. (Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)

Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>
<p>Deli Lamma (Rest & Bar) Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 6-month liquor licence.</p>

<p>Club Toto 新酒牌申請</p>	<p>同意簽發為期 6 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> i) 在任何同一時間內，處所的總人數連同職員在內不得超過 170 人； ii) 凌晨 5 時至上午 10 時，不得售賣或供應酒類飲品供顧客在處所內飲用； iii) 凌晨 5 時至上午 10 時，持牌人須確保處所內無人飲用酒類飲品；及 iv) 持牌人須於每天晚上 6 時至翌晨 3 時留駐處所當值，每週星期六例假除外。 <p>(由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘若有關處所只獲發暫准小食食肆牌照，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
