<b>YARDBIRD</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: <ul style="list-style-type: none"><li>i) Not more than 30 persons on G/F and 30 persons on Basement, including staff, shall be permitted on the premises at any one time;</li><li>ii) All doors and windows of the premises shall be kept closed after 6:00 p.m.;</li><li>iii) No liquor shall be sold or supplied for consumption on the premises after 12:00 midnight; and</li><li>iv) No music or other sound amplification or TV shall be played or permitted on the premises after 12:00 midnight.</li></ul> <p>( The premises are currently applying for a General Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )</p>

In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. <p><b>Makumba</b> Application for Transfer and Renewal of Liquor Licence</p>	<p>(a) Approved application for transfer of liquor licence; and</p> <p>(b) Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions as follows:</p> <p>i) No live music or other sound amplification or musical instrument is to be played or performed on the premises after 12:00 midnight (<i>amended</i>) ; and</p> <p>ii) The capacity limit of the premises to be assessed by the Buildings Department (<i>amended</i>) ;</p> <p>and the imposition of the following additional licensing condition:</p> <p>The licensee shall be on duty on the premises from 10:00 p.m. until the close of business every Friday, Saturday and the day preceding the public holidays;</p> <p>The other existing additional licensing conditions on the liquor licence remain unchanged.</p>
