<b>Cochrane's</b> Application for Transfer of Liquor Licence and Deletion of Additional Licensing Condition	(a) Approved application for deletion of additional licensing condition; and (b) Approved application for transfer of liquor licence with the imposition of the following additional licensing conditions: <ul style="list-style-type: none"><li>i) No liquor shall be sold or supplied for consumption on the premises between 1:00 a.m. and 11:00 a.m. (Monday to Thursday and Sunday), and between 3:00 a.m. to 11:00 a.m. (Friday to Saturday);</li><li>ii) No consumption of liquor on the premises between 2:00 a.m. and 11:00 a.m. (Monday to Thursday and Sunday), and between 4:00 a.m. to 11:00 a.m. (Friday to Saturday); and</li><li>iii) No music or other sound amplification shall be played on the premises between 11:00 p.m. and 11:00 a.m.</li></ul>
