**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>Taparella Grill</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence.  ( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )
<b>Boulangerie Bistronomique</b> 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件：  i) 晚上 11 時至翌日中午 12 時，處所的所有門窗必須保持關閉；及  ii) 晚上 11 時至翌日中午 12 時，不得售賣或供應酒類飲品供顧客在處所內飲用。  ( 由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘若有關處所只獲發暫准普通食肆牌照，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。 )

<p><b>The Loft</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions and the imposition of an additional licensing condition as follows:</p> <ul style="list-style-type: none"> <li>i) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 11:30 a.m.; (<i>amended</i>)</li> <li>ii) No patron shall be allowed on the open area of the flat roof outside the premises between 11:00 p.m. and 11:30 a.m.; (<i>amended</i>)</li> <li>iii) No speaker or other sound amplification of the premises is to be used between 11:00 p.m. and 11:30 a.m. either outside the premises or within the structure of the premises facing outside; (<i>amended</i>) and</li> <li>iv) Not more than 122 persons, including staff, shall be permitted on the premises at any one time. (<i>new</i>)</li> </ul>

<p><b>燒一燒居酒屋</b> <b>Japanese BBQ &amp; Wine House</b> 新酒牌申請</p>	<p>同意簽發為期 9 個月的酒牌，並附加下列持牌條件：</p> <p>晚上 11 時至翌日下午 5 時，不得售賣或供應酒類飲品供顧客在處所內飲用。</p> <p>(由於有關處所目前只持有暫准普通食肆牌照，按現行政策，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
<p><b>森森記餐廳菜館</b> 酒牌續期申請</p>	<p>拒絕批准酒牌續期申請。</p>
<p><b>運星點心小廚</b> <b>Lucky Star Restaurant</b> 酒牌續期申請</p>	<p>由於申請人自行撤回酒牌續期申請，故此續期申請不作處理。</p>
