| <p>Fluid Application for New Issue of Liquor Licence</p> | <p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> i) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 9:00 a.m.; and ii) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day. <p>(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p> |

If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p> |
