Casa Application for Transfer, Amendment (Addition of Bar Endorsement) and Renewal of Liquor Licence	(i) Approved application for transfer and amendment (addition of bar endorsement) of liquor licence; and (ii) Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions as follows: (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; (b) No persons shall remain on the balcony outside the premises between 11:00 p.m. and 9:00 a.m. the following day; and The other existing additional licensing condition on the liquor licence remains unchanged.
