發福啤酒坊 Fat Taps Application for New Issue of Liquor Licence	The case was not dealt with.
太平洋酒吧 Bar Pacific 酒牌續期申請	同意續發為期 3 個月的酒牌，並修訂原有的附加持牌條件及維持原有的附加持牌條件如下： (a) 下午 6 時至翌日上午 9 時，處中的所有門窗必須保持關閉； <i>(修訂)</i> (b) 凌晨 1 時至上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用； <i>(修訂)</i> (c) 晚上 11 時至翌日上午 9 時，不得使用任何揚聲器； <i>(修訂)</i> (d) 持牌人須在處所營業日的晚上 9 時至凌晨 2 時留駐處所當值(星期日除外)，而本規定並不損害酒牌一般持牌條件第(4)項的效力； <i>(現有)</i> 及 (e) 凌晨 1 時至上午 9 時，任何人不得在處所內飲用酒類飲品。 <i>(修訂)</i>

<p>Sowelu Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 9-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) The capacity limit of the premises to be assessed by the Buildings Department; (b) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; (c) No liquor shall be sold or supplied for consumption on the premises between 3:00 a.m. and 9:00 a.m.; (d) No liquor shall be consumed on the premises between 3:30 a.m. and 9:00 a.m.; and (e) No person shall be permitted to stay at the Common Flat Roof at 4/F of the premises between 9:00 p.m. and 9:00 a.m. the following day.
