Sidewalk Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing condition: The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only.
Yorkshire Pudding Soho 8 Application for Transfer and Renewal of Liquor Licence	Approved application for transfer of liquor licence and agreed to issue a 12-month liquor licence with the amendment of existing additional licensing condition as follows: All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; and The other existing additional licensing condition on the liquor licence remains unchanged.

<p>PUSH Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) No more than 109 persons, including staff, shall be permitted on the premises at any one time; (b) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; and (c) No person shall be permitted to stay at the flat roof of the premises between 11:00 p.m. and 9:00 a.m. the following day.
<p>Dog House Limited Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) No live music performance shall be allowed on the premises between 11:00 p.m. and 9:00 a.m. the following day; (b) No music or other sound amplification device or TV shall be used either outside the premises or within the premises facing outward between 11:00 p.m. and 8:00 a.m. the following day; and (c) The licensee shall be on duty on the premises between 6:00 p.m. and 12:00 midnight except on the weekly day-off.

<p>Graffiti Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) No person shall be allowed on the balcony of the premises between 6:00 p.m. on 31st October, 24th, 25th and 31st December to 6:00 a.m. the following day; and (b) No music or loudspeaker or other sound amplification device shall be played or used outside the premises or facing the outside of the premises between 11:00 p.m. and 9:00 a.m. the following day.
