Soiree Bar Application for Amendment of Additional Licensing Conditions and Renewal of Liquor Licence	(i) Refused application for amendment of additional licensing conditions; and (ii) Agreed to issue a 9-month liquor licence with the retention of existing additional licensing conditions.
CIPE@Staunton 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件： (a) 下午 6 時至翌日上午 9 時，處中的所有門窗必須保持關閉； (b) 午夜 12 時至上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用；及 (c) 凌晨 1 時至上午 9 時，不得容許任何人在處所內飲用酒類飲品。 (由於有關處所目前只持有暫准小食食肆牌照，按現行政策，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)

<p>Club 71 酒牌轉讓、修訂(更改附加持牌條件)及續期申請</p>	<p>(i) 同意批准酒牌轉讓及修訂持牌人當值時間的附加持牌條件；</p> <p>(ii) 拒絕批准修訂售酒時間的附加持牌條件以延長售酒時間至凌晨 2 時；</p> <p>(iii) 同意續發為期 9 個月的酒牌，並修訂原有的附加持牌條件如下：</p> <p>(a) 持牌人須於晚上 7 時至翌晨 2 時在處所當值，除星期一為每週例假；</p> <p>(b) 凌晨 1 時至上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用；及酒牌上其餘原有的附加持牌條件則維持不變。</p>
