八王子拉麵館 <b>PRINCE RAMEN P003</b> 考慮撤銷酒牌	撤銷酒牌。
<b>The Kitchen</b> 酒牌修訂(刪除附加持牌條件)及續期申請	(i) 拒絕批准酒牌修訂(刪除附加持牌條件)申請； (ii) 同意續發為期 9 個月的酒牌，並修訂原有的附加持牌條件如下： 持牌人須於每天下午 4 時至晚上 10 時留駐處所當值，每週一天例假除外；及 酒牌上其餘原有的附加持牌條件則維持不變。
<b>AURA Lounge</b> Application for Renewal of Liquor Licence	Agreed to issue a 3-month liquor licence with the imposition of the following additional licensing conditions:  (a) No music shall be played on the premises after 12:00 midnight;  (b) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only; and  The other existing additional licensing conditions on the liquor licence remain unchanged.

<p><b>Socialita</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>(a) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only;</li> <li>(b) The licensee shall be on duty on the premises between 7:00 p.m. and 3:00 a.m. the following day except Monday which is the weekly day-off; and</li> </ul> <p>The other existing additional licensing conditions on the liquor licence remain unchanged.</p>
<p><b>Brasserie de L'île</b> 酒牌續期申請</p>	<p>同意續發為期 12 個月的酒牌，並修訂原有的附加持牌條件及附加新持牌條件如下：</p> <ul style="list-style-type: none"> <li>(a) 凌晨 2 時至上午 7 時，不得售賣或供應酒類飲品供顧客在處所前門以內的處所範圍飲用；<i>(修訂)</i></li> <li>(b) 晚上 11 時至翌日上午 7 時，不得售賣或供應酒類飲品供顧客在處所前門以外的處所範圍飲用；<i>(新增)</i>及</li> </ul> <p>酒牌上其餘原有的附加持牌條件則維持不變。</p>
<p><b>Cacio &amp; Pepe</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.</p>
<p><b>美食園林餐廳</b> <b>Deliciousland Restaurant</b> 酒牌續期申請</p>	<p>同意續發為期 6 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> <li>(a) 持牌人須確保任何人不得在處所內營辦或進行任何形式的賭博行為；及</li> <li>(b) 持牌人須於每天晚上 11 時至翌日上午 7 時留駐處所當值，每週星期日例假除外。</li> </ul>

<p><b>葉記大排檔</b> <b>Yip Kee Cooked Food Stall</b> 新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌。  (由於有關處所目前只持有暫准普通食肆牌照，按現行政策，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
<p><b>豬仔燒烤坊</b> <b>PIGGY</b> 新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌，並附加下列持牌條件：  晚上 11 時後，處中的所有門窗必須保持關閉。</p>
<p><b>At One</b> 新酒牌申請</p>	<p>拒絕批准新酒牌申請。</p>
