EL Fishawy Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; and  (b) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 9:00 a.m. the following day.  (The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)

Piccolo Pizzeria & Bar  Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence.  (Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)
Blue Butcher Application for Transfer and Renewal of Liquor Licence	<ul> <li>(i) Approved application for transfer of liquor licence;</li> <li>(ii) Agreed to issue a 9-month liquor licence with the amendment of existing additional licensing conditions as follows:</li> <li>(a) The licensee shall ensure that no person consumes liquor on the premises between 1:00 a.m. and 9:00 a.m.;</li> <li>(b) The licensee shall be on duty on the premises from 11:00 p.m. until the close of business on every Friday, Saturday and the day preceding public holiday when the premises are open for business.</li> <li>and the imposition of the following additional licensing condition:</li> <li>(c) The licensee and the staff of the premises shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only; and</li> <li>The other existing additional licensing conditions on the liquor licence remain unchanged.</li> </ul>
