Half & Half Wine Bar and Restaurant 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件： (a) 晚上 11 時至翌日上午 9 時，處所的所有門窗必須保持關閉；及 (b) 午夜 12 時至上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用。 (由於有關處所目前只持有暫准普通食肆牌照，按現行政策，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)

Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:

- (a) All doors and windows of the premises shall be kept closed between 9:00 p.m. and 7:00 a.m. the following day;
- (b) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 9:00 a.m.;
- (c) No liquor consumption shall be allowed on the premises outside the doors and windows after 11:00 p.m.; and
- (d) No loudspeaker shall be used either outside the premises or within the premises facing outside after 11:00 p.m.

(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)

Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
