<b>Bourbon</b> 會社酒牌轉讓及修訂(更改店號)申請	同意批准會社酒牌轉讓及修訂(更改店號)申請，除維持會社酒牌上原有的附加持牌條件外，並附加下列持牌條件：  晚上 11 時至翌日上午 9 時，處所主要入口外的持牌範圍不得有顧客逗留，也不得放置桌椅及供應酒類飲品。
<b>Ilan</b> Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence.
<b>The Golden Stupa</b> Application for Transfer and Amendment (Change of Shop Sign) of Club Liquor Licence	Approved application for transfer and amendment (change of shop sign) of club liquor licence with the retention of existing additional licensing conditions.

<p><b>Volar</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 9-month liquor licence with the amendment of an existing additional licensing condition as follows:</p> <p>(a) Not more than 293 persons, including staff, shall be permitted on the premises at any one time;</p> <p>and the imposition of the following additional licensing condition:</p> <p>(b) CCTVs with recording facilities which cover the common area of the premises shall be installed and records shall be kept for at least 14 days and be available for Police inspection as and when required; and</p> <p>The other existing additional licensing condition on the liquor licence remains unchanged.</p>
