Rosie Jean's Cafe Application for New Issue of Liquor Licence	Refused application for new issue of liquor licence.
The Kitchen Application for Transfer and Renewal of Liquor Licence	(i) Approved application for transfer of liquor licence; and (ii) Agreed to issue a 9-month liquor licence with the retention of existing additional licensing conditions.

<p>Jaspa's Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions as follows:</p> <ul style="list-style-type: none"> (a) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 9:00 a.m.; (b) No table or chair shall be placed at the outdoor part of the premise between 11:00 p.m. and 9:00 a.m. the following day; (c) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the indoor part of the premises only between 11:00 p.m. and 9:00 a.m. the following day; and <p>The other existing additional licensing condition on the liquor licence remains unchanged.</p>
<p>Tivo Application for Transfer of Liquor Licence</p>	<p>Approved application for transfer of liquor licence with the amendment of an existing additional licensing condition as follows:</p> <p>No music shall be played and no sound amplification or TV shall be switched on either outside the premises or within the premises facing outside between 11:00 p.m. and 9:00 a.m. the following day; and</p> <p>The other existing additional licensing conditions on the liquor licence remain unchanged.</p>
