K Town Bar and Grill Application for Transfer of Liquor Licence	Approved application for transfer of liquor licence with the amendment of existing additional licensing conditions as follows: (a) No liquor consumption shall be allowed on the premises outside the doors and windows between 11:00 p.m. and 9:00 a.m. the following day; (b) No loudspeaker shall be switched on either outside the premises or within the premises facing outside between 11:00 p.m. and 9:00 a.m. the following day; and The other existing additional licensing conditions on the liquor licence remain unchanged.

<p>Socialita Application for Transfer and Amendment (Change of Shop Sign and Additional Licensing Conditions) of Liquor Licence</p>	<p>(i) Refused application for amendment of additional licensing conditions;</p> <p>(ii) Approved application for amendment (change of shop sign) of liquor licence;</p> <p>(iii) Approved application for transfer of liquor licence with the amendment of an existing additional licensing condition as follows:</p> <p>(a) No music shall be played and no loudspeaker or sound amplification device outside the interior of the premises shall be switched on between 11:00 p.m. and 9:00 a.m. the following day;</p> <p>and the imposition of the following additional licensing condition:</p> <p>(b) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only; and</p> <p>The other existing additional licensing conditions on the liquor licence remain unchanged.</p>

<p>明珠卡拉 OK PEARL KTV 新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> (a) 持牌人須於每天晚上 7 時至翌晨 2 時留駐處所當值，每週星期日例假除外； (b) 不得容許 18 歲以下人士進入處所； (c) 處所須在其內的公用地方裝設附錄影設施的閉路電視，而所有閉路電視錄影帶須保留最少 14 天，供警方在有需要時查看； (d) 在任何同一時間內，處所的總人數連同職員在內，不得超過 173 人；及 (e) 持牌人須在牌照的屆滿日期當日或之前參加及修畢酒牌局舉辦的酒牌研討會，並取得酒牌局發出的出席證書。在任何時間，在酒牌局或警務處處長或任何代酒牌局/警務處處長行事的公職人員要求下，持牌人須將該出席證書交出查閱。此外，持牌人須在牌照的屆滿日期之前向酒牌局提交出席證書副本，用以支持牌照續期申請（如有的話）。

<p>M1 酒牌轉讓及續期申請</p>	<ul style="list-style-type: none"> (i) 同意批准酒牌轉讓申請； (ii) 同意續發為期 6 個月的酒牌，除維持酒牌上原有的附加持牌條件外，並附加下列持牌條件： <ul style="list-style-type: none"> (a) 持牌人須於每天晚上 7 時 30 分至翌晨 3 時留駐處所當值，每週星期日例假除外；及 (b) 持牌人須盡應盡的努力確保處所內無人吸煙或攜帶燃著的香煙、雪茄或煙斗。
