Liquor Licensing Board's Decision on Open Hearing Cases

<b>Café O</b> Application for Transfer, Amendment (Change of Shop Sign, Nature of Business and Additional Licensing Condition) and Renewal of Liquor Licence	(i) Refused application for amendment of additional licensing condition; (ii) Approved application for transfer and amendment (change of shop sign and nature of business) of liquor licence; and (iii) Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions and the imposition of the following additional licensing conditions:  (a) No person shall be allowed to stay on the yard of the premises between 11:00 p.m. and 9:00 a.m. the following day; and  (b) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only.  ( The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )
