Liquor Licensing Board's Decision on Open Hearing Cases

The Woods Application for New Issue of Liquor Licence	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none">(a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day;(b) No liquor shall be sold or supplied for consumption on the premises between 1:00 a.m. and 9:00 a.m.;(c) No consumption of liquor shall be allowed on the premises between 2:00 a.m. and 9:00 a.m.;(d) The licensee shall ensure that liquor sold or supplied is to be consumed on the premises only; and(e) Not more than 84 persons, including staff, shall be permitted on the premises at any one time. <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>

The Licensee shall submit a copy of certificate of attendance to the Liquor Licensing Board before 10 September 2014 and shall produce the certificate of attendance for inspection upon demand by the Liquor Licensing Board or the Commissioner of Police or any public officer acting on its/his behalf at any time. The Liquor Licensing Board may consider revoking the liquor licence should the licensee fail to attend and complete the seminar on or before 10 September 2014; and</p> <p>The other existing additional licensing conditions on the liquor licence remain unchanged.</p> <p>(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>
