Tarre Application for Transfer and Amendment (Change of Shop Sign and Additional Licensing Condition) of Liquor Licence	(i) Refused application for amendment of additional licensing condition; (ii) Approved application for amendment (change of shop sign) of liquor licence; (iii) Approved application for transfer of liquor licence with the amendment of an existing additional licensing condition as follows: (a) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 7:00 a.m. the following day; and the imposition of the following additional licensing condition: (b) The licensee shall ensure that liquor sold or supplied is to be consumed on the premises only; and The other existing additional licensing conditions on the liquor licence remain unchanged.

<p>一宝香港 IPPOH HK Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) All doors and windows of the premises shall be kept closed between 6:00 p.m. and 9:00 a.m. the following day; (b) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 9:00 a.m.; and (c) No consumption of liquor shall be allowed on the premises between 12:30 midnight and 9:00 a.m. <p>(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>

<p>Street Meat Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; (b) No speaker or other sound amplification shall be switched on either at the open space of the premises or facing outside of the premises between 11:00 p.m. and 9:00 a.m. the following day; (c) No liquor shall be sold or supplied for consumption on the premises between 2:00 a.m. and 9:00 a.m.; (d) No person shall be allowed to stay on the common yard of the premises between 11:00 p.m. and 9:00 a.m. the following day; and (e) No consumption of liquor shall be allowed on the open space or outside the doors of the premises between 11:00 p.m. and 9:00 a.m. the following day. <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
