**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案</b> <b>Case</b>	<b>酒牌局的決定</b> <b>Liquor Licensing Board's Decision</b>
<b>Sushi O</b> Application for Transfer and Renewal of Liquor Licence	Adjourned the hearing to 28 October 2014.
<b>Rummin Tings</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; and  (b) No liquor shall be sold or supplied for consumption on the premises between 2:00 a.m. and 9:00 a.m.  ( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )

<p><b>Honi Honi</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 9-month liquor licence with the retention of existing additional licensing conditions and the imposition of the following additional licensing condition:</p> <p>The Licensee shall attend and complete a seminar for liquor licensing organized by the Liquor Licensing Board after the first day of January 2014 and obtain a certificate of attendance issued by the Liquor Licensing Board on or before the expiry of this Licence. The Licensee shall produce the certificate of attendance for inspection upon demand by the Liquor Licensing Board or the Commissioner of Police or any public officer acting on its/his behalf at any time and submit a copy of certificate of attendance to the Liquor Licensing Board in support of an application for renewal of licence, if any, before the expiry date of this Licence.</p>
<p><b>Aberdeen Street Social</b> Application for Transfer of Liquor Licence</p>	<p>Approved application for transfer of liquor licence with the retention of existing additional licensing conditions.</p> <p>( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )</p>
<p>北京 <b>Beijing Club</b> 酒牌轉讓及續期申請</p>	<p>(i) 同意批准酒牌轉讓申請；</p> <p>(ii) 同意續發為期 12 個月的酒牌，除維持酒牌上原有的附加持牌條件外，並附加下列持牌條件：</p> <p>(a) 持牌人須於每天晚上 9 時至翌晨 5 時留駐處所當值，每週星期日例假除外；及</p> <p>(b) 持牌人須在牌照的屆滿日期當日或之前參加及修畢酒牌局自 2014 年 1 月 1 日後舉辦的酒牌研討會，並取得酒牌局發出的出席證書。在任何時間，在酒牌局或警務處處長或任何代酒牌局/警務處處長行事的公職人員要求下，持牌人須將該出席證書交出查閱。此外，持牌人須在牌照的屆滿日期之前向酒牌局提交出席證書副本，用以支持牌照續期申請（如有的話）。</p>

<b>J P CLUB</b> 酒牌轉讓及續期申請	(i) 拒絕批准酒牌轉讓申請；及 (ii) 酒牌續期申請不作處理。
太平洋酒吧 <b>Bar Pacific</b> 酒牌續期申請	同意續發為期 12 個月的酒牌，並維持酒牌上原有的附加持牌條件。
