**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案</b> <b>Case</b>	<b>酒牌局的決定</b> <b>Liquor Licensing Board's Decision</b>
<b>Rosie Jean's Cafe</b> Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.
<b>Hot Shot</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; and  (b) No liquor shall be sold or supplied for consumption on the premises between 2:00 a.m. and 9:00 a.m.  ( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )

<p><b>華豐燒臘專家</b> <b>Wah Fung</b> 新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌，並附加下列持牌條件：</p> <p>(a) 晚上 11 時至翌日上午 6 時，處所的所有門窗必須保持關閉；及</p> <p>(b) 午夜 12 時至上午 10 時，不得售賣或供應酒類飲品供顧客在處所內飲用。</p> <p>(由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘若有關處所只獲發暫准普通食肆牌照，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
<p><b>Twist</b> 酒牌轉讓、修訂(更改店號及業務性質、取消酒吧批註及刪除附加持牌條件)及續期申請</p>	<p>(i) 拒絕批准酒牌修訂(刪除附加持牌條件)申請；</p> <p>(ii) 同意批准酒牌轉讓及修訂(更改店號及業務性質及取消酒吧批註)申請；</p> <p>(iii) 同意續發為期 12 個月的酒牌，並修訂原有的附加下列持牌條件如下：</p> <p>晚上 11 時至翌日上午 8 時，處所的所有門窗必須保持關閉；及</p> <p>酒牌上其餘原有的附加持牌條件則維持不變。</p>
