Liquor Licence

Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:

- (a) All doors and windows of the premises shall be kept closed between 9:00 p.m. and 9:00 a.m. the following day;
- (b) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 9:00 a.m.; and
- (c) The licensee shall ensure that no person consumes liquor on the premises between 1:00 a.m. and 9:00 a.m.

(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)

- (c) No sound amplification device or TV shall be switched on and no music shall be played on the premises between 11:00 p.m. and 9:00 a.m. the following day; and
- (d) No liquor shall be sold or supplied and no liquor consumption shall be allowed on the cockloft of the premises at any time.

(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence.
