Liquor Licensing Board's Decision on Open Hearing Cases

個案 Case	酒牌局的決定 Liquor Licensing Board's Decision
Little Burro Application for Amendment of Additional Licensing Conditions and Renewal of Liquor Licence	(i) Refused application for amendment of additional licensing conditions specifying the liquor selling hours and time for music playing and use of amplification device; (ii) Approved application for amendment of additional licensing condition specifying the liquor consumption hours; (iii) Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions as follows: (a) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 9:00 a.m. the following day; (b) No consumption of liquor on the premises shall be allowed between 12:00 midnight and 9:00 a.m.; (c) No sound simplification device shall be switched on and no music shall be played on the premises between 11:00 p.m. and 9:00 a.m. the following day; and The other existing additional licensing conditions on the liquor licence remained unchanged.
Old China Hand Application for Transfer of Liquor Licence	Approved application for transfer of liquor licence with the retention of existing additional licensing conditions.

<p>Cali-Mex Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing condition:</p> <p style="padding-left: 40px;">No speaker installed outside the doors of the premises and facing the street shall be switched on between 9:00 p.m. and 9:00 a.m. the following day.</p> <p>(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>
<p>Jaspa's Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.</p>

<p>The Tarvern Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) All doors and windows of the premises shall be kept closed between 10:00 p.m. and 9:00 a.m. the following day; and (b) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only. <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
