<b>Ping Pong</b> Application for Amendment of Additional Licensing Condition and Renewal of Liquor Licence	(i) Refused application for amendment of additional licensing condition of liquor licence; and (ii) Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.
<b>208</b> Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions and the imposition of the following additional licensing condition:  No tables, chairs, heating facilities and/ or structures shall be placed at the shop front area.

<p><b>DACHA</b></p> <p>Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>(a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 7:00 a.m. the following day;</li> <li>(b) No liquor shall be sold or supplied for consumption on the premises between 2:00 a.m. and 9:00 a.m.; and</li> <li>(c) No consumption of liquor shall be allowed on the premises between 3:00 a.m. and 9:00 a.m.</li> </ul> <p>( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )</p>
