Liquor Licensing Board's Decision on Open Hearing Cases

個案 Case	酒牌局的決定 Liquor Licensing Board's Decision
Tantra Services Limited Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.
The Woods Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.
Deligator Application for Transfer of Liquor Licence	Approved application for transfer of liquor licence with the retention of existing additional licensing conditions. (Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)

<p>Ted's Lookout 酒牌轉讓、修訂(更改附加持牌條件)及續期申請</p>	<p>(i) 拒絕批准修訂有關售酒時限、飲用酒類飲品時限及任何人均不得在處所門外的持牌範圍逗留時限的附加持牌條件；</p> <p>(ii) 同意批准酒牌轉讓申請及修訂有關持牌人當值時間的附加持牌條件；</p> <p>(iii) 同意續發為期 12 個月的酒牌，並修訂原有的附加持牌條件及附加新持牌條件如下：</p> <p>(a) 持牌人須於每天晚上 7 時至翌晨 1 時留駐處所當值，每週一天例假除外；(修訂)</p> <p>(b) 晚上 11 時至翌日上午 9 時，處所內不得將擴音設備開著，也不得演奏或播放音樂；(新增)及</p> <p>酒牌上其餘原有的附加持牌條件則維持不變。</p>
<p>大龍鳳 酒牌續期申請</p>	<p>同意續發為期 6 個月的酒牌，並維持酒牌上原有的附加持牌條件。</p>
<p>MALTY(WP) 新酒牌申請</p>	<p>同意簽發為期 9 個月的酒牌，並附加下列持牌條件：</p> <p>(a) 晚上 11 時至翌日上午 9 時，處所的所有門窗必須保持關閉；</p> <p>(b) 持牌人須確保售賣或供應的酒類飲品只供顧客在處所內飲用；</p> <p>(c) 凌晨 3 時至上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用；及</p> <p>(d) 凌晨 4 時至上午 9 時，持牌人須確保處所內無人飲用酒類飲品。</p> <p>(由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘若有關處所只獲發暫准小食食肆牌照，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
