BA B JOHNNY 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件： (a) 晚上 11 時至翌日上午 9 時，處所的所有門窗必須保持關閉；及 (b) 午夜 12 時至上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用。 由於有關處所目前只持有暫准普通食肆牌照，按現行政策，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。

<p>HQ by Terrace Concepts Application for Transfer, Amendment of Additional Licensing Conditions and Renewal of Liquor Licence</p>	<p>(i) Refused application for amendment of additional licensing condition for relaxation of the capacity limit from 110 persons to 172 persons;</p> <p>(ii) Approved application for transfer of liquor licence and amendment of additional licensing condition specifying the time for patrons to stay in the open area of the flat roof outside the premises;</p> <p>(iii) Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions as follows:</p> <p>(a) No patron shall be allowed on the open area of the flat roof outside the premises between 1:00 a.m. and 9:00 a.m.;</p> <p>(b) Not more than 155 person, including staff, shall be permitted on the premises at any one time;</p> <p>(c) The Licensee shall attend and complete a seminar for liquor licensing organized by the Liquor Licensing Board after the first day of January 2014 and obtain a certificate of attendance issued by the Liquor Licensing Board on or before the expiry of this Licence. The Licensee shall produce the certificate of attendance for inspection upon demand by the Liquor Licensing Board or the Commissioner of Police or any public officer acting on its/his behalf at any time and submit a copy of certificate of attendance to the Liquor Licensing Board in support of an application for renewal of licence, if any, before the expiry date of this Licence; and</p> <p>The other existing additional licensing conditions on the liquor licence remained unchanged.</p>
